Terms and Conditions

- The 2021/2022 Annual Seasonal Golf Pass is valid from November 1, 2021 through October 31, 2022 and the 6 Month plan is valid from November 1, 2021 through April 31, 2022.
- Seasonal Golf Passes are non-transferrable and non-refundable.

Mission Royale reserves the right to block out 1 hour of tee times Monday through Friday and up to 2 hours of tee times Friday through Sunday to be used for club purposes.
- Unlimited golf privileges do not cover green fees for tournaments, special events or club events except as specifically designated by management.
- Discounts for Corporate Member guests only apply to the guests in the Corporate Members foursome and are not valid for league play, tournaments, special events or club events.
- Discounts on merchandise do not apply to already discounted items.
